#### **COMMUNITY REMINDERS**

#### **Absence Reminders**

If you'll be away for more than 30 days, please notify the Community Management Office.

#### Fire Pit and Chiminea Safety

Portable fire pits and chimineas are permitted in backyards only and must follow all installation, distance, and safety regulations.

- Fires must be small and supervised by an adult at all times.
- Maintain at least 15 feet of clearance from any structure or combustible material.
- Use only manufacturer-approved equipment and follow all local and installation fire regulations.
- Fire pits are not permitted in common areas, front, or side yards.
- Please note: use is prohibited during burn bans issued by local authorities.

#### Winterizing Your Home for Cold Weather Ahead

When temperatures drop, please remember the following to prevent frozen pipes and property damage:

- Never turn your heat off or lower than 65° F, especially if you are planning on leaving your home. You must keep your heat turned on.
- Disconnect and store outdoor hoses properly.
- Lock all windows and doors before leaving.
- Avoid visible package buildup by pausing deliveries or having someone collect them.
- **Maintain** your lawn and fenced areas. Please ensure pet care is arranged if you are away.
- Check the forecast before traveling and plan accordingly for freezing conditions. You
  must drip faucets and open cabinet doors where plumbing is located during a freeze
  warning to prevent pipes from freezing.

#### **Maintenance Reminders**

The Maxwell Family Housing Maintenance Team is here to keep your home safe and comfortable, and we're just a request away!

- Submit **non-emergency service requests** through the call center or resident portal.
- For emergencies (like flooding), maintenance may enter your home without prior notice.
- We are available 24/7 for emergency issues. Please do not hesitate to reach out!

#### **Emergency Maintenance Requests After Hours**

For Emergency Maintenance needs after hours, please do not use the resident portal. It is not monitored outside of business hours. For urgent matters, please contact our emergency line directly at (334) 686-0444. This helps us respond quickly and prevent damage to homes or personal belongings.

#### **HVAC Tips**

When switching between air conditioning and heating, please follow these steps:

**Friendly reminder:** Turning your heat on. When turning on your heat for the first time, you may experience a slight smell, and in some cases, your smoke alarms may briefly go off. This is normal, as dust can settle on heating components throughout the warmer months and burns off when the heat is turned on for the first time in the cold season.

- Turn your system off.
- Allow it to idle for a few minutes.
- Choose your desired mode (Heat or Cool) and then set it back to on or auto.



#### Southeast Landscape Leaf Removal

Southeast Landscape has begun leaf removal services for the season. Leaves will be removed during regular yard service visits. We've shared feedback with the landscaping team regarding attention to detail, particularly about blowback and debris on patios. We look forward to continued improvement.
